

# Local rules Gantrisch HF 2025

## 1. General

1.1 The regulations are based on the SHV regulations G Swiss Cup Hike & Fly and the local regulations Gantrisch hike&fly listed below. In the event of disputes between the participant and the jury, the principles mentioned form the basis for any judgments to be made.

1.2 The regulations apply to all participating athletes.

1.3 The Gantrisch Hike & Fly organizing committee, hereinafter referred to as OK, reserves the right to change the rules if necessary up until the start of the race. Information about this will be provided at the obligatory briefing.

1.4 The regulations are deliberately written in male and female terms. Of course, all rules apply to both sexes.

1.5 The event is not for profit. The entry fee is used exclusively for the expenses and costs incurred by the organization, the prize money, the souvenir prizes, the live tracking system, the evaluation and for the catering in the start/finish area.

1.6 The OC is responsible for the content of the website, the registration procedure, the schedule, the task distribution, the competition and weather briefing online on the evening before the competition, the service at the start and finish, the participant prices,

the provision of the live tracking and evaluation system with the app "HnF - Switzerland" (Android and iOS) for creating the ranking list and improving athlete safety and the support at the start and finish as well as at the control points.

1.7 The athletes are responsible for their flight and running equipment, the right clothing, orientation in the terrain, the choice of suitable take-off and landing sites, the assessment of the weather and wind conditions on site, a valid liability and accident insurance policy, the functionality of the "HnF Switzerland" app, the signing of the signboards, and generally for all decisions made during the ongoing competition.

1.8 The athletes are aware of the considerable risks that arise from the "Gantrisch hike&fly" facility. They accept these as an unavoidable part of the event.

1.9 Registration and payment of the entry fee takes place online via the website [gantrisch-hikeandfly.ch](http://gantrisch-hikeandfly.ch), or HnF Switzerland. The starting place is booked as soon as your payment has been received.

1.10 If the competition cannot take place due to force majeure, the registration including the entry fee is valid for the alternative date of June 15, 2025. If the competition cannot take place even then, there is no right to a refund of the entry fee.

1.11 Refund of entry fee: If you cancel your registration for the event before 11:59 p.m. on June 1, 2025, the entry fee will be refunded, minus a processing fee of CHF 20. After that, only upon presentation of a doctor's certificate, also minus a processing fee of CHF 20.

1.12 The WhatsApp group is used to disseminate relevant information before and during the competition. The athletes must join the group.

1.13 Jury: The jury consists of the competition director, the person responsible for the evaluation and an athlete representative. The athlete representative is determined at the briefing.

## 2. local regulations Gantrisch hike&fly

2.1 Dogs and other animals are not allowed.

2.2 A maximum of 50 athletes are allowed to take part in the competition.

2.3 The competition will be held as a score race in accordance with regulations G. The three control points (CPs) must also be passed on the ground and the signboard must be signed. In addition, the start-finish area must be passed on the ground once during the competition. This must not be done immediately before crossing the finish line, but at least one more turn point or control point must be reached afterwards.

2.4 The competition is judged in two categories: women, men. The top three women and men will each receive non-cash and cash prizes worth around CHF 2000.

2.5 The briefing will take place online on Friday evening (procedure, weather, terrain, etc.). It is compulsory for all participants.

2.6 The paths and the TP are not marked. Each participant is responsible for their own orientation in the terrain. The course overview shows a section of the Swisstopo map 1:100000 that is not to scale. In open terrain, only existing paths and mown meadows may be used. Forests may also be used off-path.

2.7 Anyone who ends the race early must immediately inform the OK by WhatsApp, telephone or SMS.

## 3. Safety

3.1 Each participant is responsible for the airworthiness of their own equipment.

3.2 Each participant must have sufficient accident insurance and a valid hang glider liability insurance policy.

3.3 The OC reserves the right to make changes to the route, the TP and the times, to interrupt the competition or to cancel the competition entirely, even on the day of the competition, especially if weather conditions require this. All adjustments will be communicated at the briefing before the start. During the competition, the OC reserves the right to make further changes for safety reasons, including early termination, and to communicate this via the Whatsapp group.

3.4 All athletes study the organizer's safety concept. In the event of an emergency, everyone is asked to act in accordance with this concept. Download Safety Concept 2024 <http://gantrisch-hikeandfly.ch/wp-content/uploads/2024/03/Safety-Concept-2024.pdf>

3.5 After the start, the OC informs the competitors about important changes or competition adjustments via the Whatsapp group.

3.6 If another competitor has obvious problems or even an accident, he or she must be given immediate help and alerted in accordance with the safety concept.

3.7 We appeal to every participant to be fair towards the other competitors and the OC.

#### 4. Exclusion of liability and waiver

4.1 ALL LIABILITY CLAIMS BY PARTICIPANTS AGAINST THE OC ARE EXPRESSLY REJECTED.

4.2 As a participant, I am responsible for my own actions and decisions and know my abilities and limits.

4.3 I have read the information about the competition and these regulations. I agree to the rules and instructions contained therein.

4.4 As a participant, I am aware that I am taking a risk when practicing paragliding and in competitions in general. I am taking part in this paragliding competition on my own responsibility and at my own risk.

4.5 The organizer and event organizer of the Gantrisch hike&fly, namely the entire OC under Bernhard Senn, their assistants and the jury, is not liable for any damage to property or personal injury suffered by all participants.

4.6 I agree that images, start and ranking lists may be published on the website [www.gantrisch-hikeandfly.ch](http://www.gantrisch-hikeandfly.ch) and other media.

4.7 I agree to disclose my location via my smartphone during the race in order to create the ranking list and improve safety.

4.8 By signing before the start, I agree to the information provided and the regulations.
